INDEMNITY, LIABILITY, CONDITIONS AND RESPONSIBILITIES OF MERCHANT

Merchant agrees to indemnify, defend, and hold RoSFest Inc, its landlord, building owners (Sarasota Opera House), officers, employees, and agents harmless of and from any damages, liabilities, costs, penalties, or expenses arising out of and/or resulting from the rental and use of the premises, including but not limited to, the personal guarantee of provision, service, and dispensing of payment by renter, its employees.

In the event RoSFest Inc, its landlord, building owners, officers, employees and/or agents, are required to file any action in court to enforce any provisions of this agreement, Merchant agrees to pay RoSFest Inc, its officers, landlord, building owners, employees and/or agents, all reasonable attorney fees, court fees, and costs of suit incurred by RoSFest Inc, including all collection expenses and interest due.

DEPOSIT/DONATION FEES

A refundable \$100 damage deposit is due prior to the event time and will be collected prior to allowing Merchant to move into the assigned space/table. The damage deposit will be refunded in full upon departure if no damage(s) has incurred.



Fifty (50) percent of the table(s)/space(s) donation, and a signed contract will be required prior to assigning event table/space(s). The remaining fifty (50) percent balance of the Merchant donation is due thirty (30) days prior to your event. No terms are implied or granted, and no setup will be allowed to commence until full payment of the space/table donation is received.

SITE DECORATION

RoSFest Inc, wants to make every event here a special and welcome experience. Therefore, every effort will be made to allow Merchant to prepare decorations reflecting their creative requirements. No nails, screws, staples, or penetrating items are to be used on the walls or floors of the venue or Merchant space. Glitter or foil (non-paper) confetti is not allowed on site. Only "low-tack tape" is allowed on our floors and walls. Any damage will be charged after the event.

CLEANING, TRASH, AND EQUIPMENT REMOVAL

Sarasota Opera House will provide a clean space to Merchant at the commencement of the assigned event time. Within one (1) hour prior to the end of the event, Merchant is required to return the space to the same clean condition in which it was found. Failure to remove debris or clean space may result in additional fees to the Merchant and may be deducted from deposit.

CANCELLATION

All donations are non-refundable. All donations are 100% tax-deductible.

CITY, COUNTY, STATE, AND FEDERAL LAWS

Renter agrees to comply with all applicable City, County, State, and Federal laws and shall conduct no illegal act on the premises. This is always a drug free and non-smoking facility, there are no exceptions. Merchant shall not sell alcohol on premises at any time. Merchant may not serve alcohol on the premises at any time. RoSFest Inc., reserves the right, in its exclusive discretion, to expel anyone who, in its judgment, is intoxicated or under the influence of alcohol or drugs, or who shall, in any manner, do or participate in any act jeopardizing the rights, use permit, or insurability of RoSFest Inc., or the safety of its staff, guests, or building contents.

CONDUCT

Absolutely no drug use or smoking of any kind tolerated on premises or within twenty-five (25) feet of the building including loitering outside on the sidewalk at any time during the event. Disparaging remarks or any type of physical violence will not be tolerated and will be cause for immediate expulsion. Merchant and guests shall always use the premises in a considerate manner.
